The official autopsy of Stephon Clark, who died in March after being shot by California police officers, has revealed a different picture of the shooting than a private family examination portrayed.

The Sacramento County coroner's report, released Tuesday, concluded Clark was shot seven times -- with three of the bullets entering his back.

Clark, 22, was shot March 18 standing in his grandmother's yard by Sacramento officers responding to a vandalism call. Police said he'd refused orders to drop his cellphone, which the officers mistook for a weapon.

The Clark family, after a private autopsy, said previously he'd been shot eight

Since then the competitors of free-to-the-home broadcast television have been among the loudest voices crying "the sky is falling," and the government -- the FCC and DOJ - should deny approval of the merger.

This chorus has been joined by adversaries wishing to create political division, and seeking to pull the power-levers of government to have Sinclair "investigated" for "bias" and claims of "fake news." Let's get some context and perspective. Free-to-the-home television in America, one of the nation's most heavily regulated industries, is in a fight for its life.

There is fierce and expanding competition everywhere in the media marketplace: from pay television (DirecTV, Dish Network, Comcast, AT&T, Verizon, Charter), the big five networks (NBC, CBS, ABC, Fox and CNN), the Studios (Disney, Sony, Paramount), and over-the-top internet services (Facebook, Amazon, Apple, Netflix and Google).

All of these competitors have far bigger budgets and deeper pockets than Sinclair and Tribune combined (under \$4 billion vs. more

None of these companies, however, are subject to any rules that restrict how many ARMSTRONG WILLIAMS TV homes they can reach, as

All of them aggregate news, produce video and widely distribute content that directly competes with broadcast television in the U.S.A. Yet these competitors face little or no government imposed limitation on how many assets they can broadcasters who are govof federal rules that hamper their ability to compete in a new and rapidly changing market. Broadcast groups such as Sinclair, Nexstar, Gray, Tegna, Meredith, Ion, Univision, and others, cannot own stations that broadcast to more than 39 percent and forgetting a similar illof American homes.

We need affordable common defense

The Pentagon unveiled its latest National Defense Strategy in January.

The NDS very much was the product of the experience and thinking of Secretary of Defense and former Marine Gen. Jim Mattis. Mattis has a unique understanding of both the practice and study of war, including multiple combat tours in Afghanistan and Iraq and a personal professional library of over 10,000 books. To fund the NDS, Congress will appropriate nearly \$1.5 trillion over the next two years. That money is sorely needed to overcome the stress of nearly 17 years of high-tempo combat operations and insufficient resources to keep the current force ready and capable of conducting all its difficult and dangerous assignments. To their credit, the Joint Chiefs of Staff have been extremely candid and outspoken in warning about the declining condition of the U.S. military.

But the dangers are three-fold. First, this surge of spending will not last. Nor is it sufficient to redress all the past problems of readiness and the need to modernize the military with new weapons systems, let alone grow it.

However, the Pentagon leadership knows that asking Congress for even more money or complaining that the increases may not be enough is politically impracticable if not destructive. Second, in calling for a force that is more "lethal, agile and resilient" and able to fight and win in highly contested battlegrounds in land, sea, air, space and cyber, without long term, sustained increases in defense spending, this plan will be unaffordable. Third, the administration has cemented its plans in its National Security Strategy and the NDS. Changing in mid-stream likewise is a political bridge too far.

very daunting task. The force can be made more lethal, agile and resilient.

However, thinking must start now about what happens when budgets become more constrained and even cut as interest payments on the national debt will require across-the-board reductions in spending. The NDS has set out a few ways to accomplish this. The other lines of action in the NDS are greater reliance on allies and friends and making major reforms in process to ensure that every defense dollar is spent with maximum effectiveness and efficiency. The Pentagon is proposing to field forces capable of defeating these A2AD defenses. That, however, is likely to prove far more costly than future defense budgets will allow. What is needed is a strategy to contain Russian and Chinese military forces to home waters and borders. And here geography, whether in Europe where Russia is "surrounded" by NATO allies or in the Pacific where the "first island chain" from the tip of Alaska to the Tonkin Gulf form natural barriers to Chinese expansion is on our side. Concurrently, reform must be a high priority. The reality is that the Pentagon has undergone countless attempts at reform and conducted even more studies on making the department more efficient. None has really ever worked. The only pragmatic solution is to focus on the nightmarish number of federal and defense acquisition regulations. In fact, it is a wonder that the Pentagon can function at all with the burdens of excessive rules and regulations, understanding that a certain number are essential to ensure proper oversight. Streamlining and codifying these vast tomes is certainly achievable and practical. Relations with Russia are at a low point and are likely to worsen. The prospect of a trade war with China looms.

Hard to quit Facebook

Here we go again: another Facebook controversy, yet again violating our sense of privacy by letting others harvest our personal information. This flare-up is a big one to be sure, leading some people to consider leaving Facebook altogether. But the company and most of its over 2 billion users will reconcile. The vast majority will return to Facebook, just like they did the last time and the many times before that. As in all abusive relationships, users have a psychological dependence that keeps them hooked despite knowing that, at some level, it's not good for them.

Decades of research has shown that our relationship with all media, whether movies, television or radio, is symbiotic: People like them because of the gratifications they get from consuming them -- benefits like escapism, relaxation and companionship. The more people use them, the more gratifications they seek and obtain.

With online media, however, a consumer's use provides data to media companies so they can serve up exactly what would gratify her most, as they mine her behavior patterns to tailor her online experiences and appeal to her individual psychological needs.

Aside from providing content for our consumption, Facebook, Twitter, Google -- indeed all interactive media -- provide us with new possibilities for interaction on the platform that can satisfy some of our innate human cravings.

Interactive tools in Facebook provide simplified ways to engage your curiosity, broadcast your thoughts, promote your image, maintain relationships and fulfill the yearning for external validation. Social media take advantage of common psychological traits and tendencies to keep you clicking -- and revealing more of yourself.

Here's why it's so hard, as a social network user, to pull the plug once and for all.

Snooping through an open window

The more you click, the more you can keep an eye on others.

This kind of social searching and surveillance are among the most important gratifications obtained from Facebook. Most people take pleasure in looking up others on social media, often surreptitiously.

The psychological need to monitor your environment is deep-rooted and drives you to keep up with news of the day -- and fall victim to FOMO, the fear of missing out.

Even privacy-minded senior citizens, loath to reveal too much about themselves, are known to use Facebook to snoop on others.

What if Facebook never nudged you?

What if algorithms never gave you recommendations or suggestions? Would you still perform those actions?

According to nudge theory, you'd be far less likely to take action if you're not encouraged to do so. If Facebook never nudged you to attend events, add friends, view others' posts or wish friends Happy Birthday, it's unlikely you would do it, thereby diminishing your social life and social circles. Facebook knows this very well. Just try deleting your Facebook account and you will be made to realize what a massive repository it is of your private and public memory. When one of us tried deactivating her account, she was told how huge the loss would be -- profile disabled, all the memories evaporating, losing touch with over 500 friends. On the top of the page were profile photos of five friends, including the lead author of this article, with the line "S. Shyam will miss you." The Conversation This is like asking if you would like to purposely and permanently cut off ties with all your friends. Now, who would want to do that?

ne year mark for REAL ID **RALEIGH** – In just one year, more than 445,000 North Carolinians have obtained REAL IDs from the N.C. Division of Motor Vehicles since the new identification debuted on May 1, 2017. REAL ID is the single form of identification that meets new federal security requirements for boarding a commercial airplane and visiting federal facilities, including military installations. The requirements are already being enforced at Camp Lejeune. The total number of REAL ID driver licenses and identification cards issued todate is 445,401. Currently,


REAL IDs account for 18 percent of all issuances. The N.C. REAL ID is just like a traditional North Carolina license or ID, but has a star in the upper right corner. The federal REAL ID Act established the requirements and the program is administered by the U.S. Department of Homeland Security. To obtain their first REAL ID, residents must bring the following verification documents to a local driver license office:

One (1) proof of identity, date or birth and/or legal presence (lawful status): certified birth certificate or unexpired U.S. Passport

One (1) proof of name change: certified marriage license or certified divorce decree One (1) proof Social Security number: Social Security card, W-2 or 1099 tax form with full name and number Two (2) proofs of current address: driver license, vehicle registration card, voter registration card, cable bill, utility bill or bank statement

DMV officials have a few tips for residents preparing to visit the DMV office for their first REAL ID: If your license or ID card expires in 2020, plan to renew your license as a REAL ID within six months of your expira-

tion date. Your renewal fee will be the same. If your license or ID card expires after 2020, make an appointment now to obtain a REAL ID for \$13. Once your card expires, you can renew it online. Bring your certified marriage license or court documents if your current name does not match your certified birth certificate or U.S. Passport. Decrease your wait time by scheduling an appointment at (919) 715-7000 for any driver license office. Residents who choose not to get a REAL ID will have a license or ID card noted with "Not for Fed

County coroner Kimberly Gin said last week she enlisted the help of multiple pathologists to clarify "erroneous information that was released from the private autopsy."

Dr. Gregory Reiber, one of three who reviewed the coroner's autopsy, said its findings also differ about where the first shot hit

Clark. He said it conflicts with the private autopsy regarding the direction Clark was facing in relation to the officers.

Dr. Bennet Omalu, the pathologist hired by the Clark family, had previously concluded Clark was not facing toward the officers when they started shooting. Reiber disagreed, saying the first shot likely hit his left thigh "either as Clark was walking toward the officers' position with his left thigh raised, or Reiber wrote.

Reiber said police video footage of the shooting supports his conclusions.

At no time does the video show Clark to have the left side of his body facing the officers' position as shots are fired, nor does the video show him turning around from a left-facing position, still upright, and putting his back squarely toward the officers as there are further shots fired,"

"The video evidence provides clear refutation of Omalu's description of Clark's positioning during the shooting."



Museum memorializing black Lynching victims opens in Alabama

The National Memorial for Peace and Justice and the Legacy Museum has opened to teach American history never published in textbooks.

The museum is a memorial to the documented 4,400 African-Americans murdered in terrorist lynchings, which included beatings, drownings and being burned at the stake by Whites between 1877 and 1950 in 12 Southern

States including Alabama, Arkansas, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee, Texas and Virginia.

of columns, two for each county where a lynching was documented. Equal Justice Initiative (EJI) initially reported that 3,959 African-Americans were victims of terrorist lynchings in the 12 states but added to the number as more victims became known.

The lynchings forced Blacks to flee in terror from the South to the North. "Black people living in Oakland, California, Chicago, and New York are refugees from terror.

They fled the South to escape lynching," said Bryan Stevenson, executive director of the Equal Justice Initiative, which had the museum constructed to pull the wraps off an untold story of America's history.

The story will make Lynchings, for example, some Blacks as well as Whites uncomfortable and even angry.

Historically, however, lynchings entertained some Whites. Some made a day of it, attending with picnic baskets.

The museum, which is located in Montgomery.

Alabama, the state's capital and one-time seat of the Confederacy, was founded by The Equal Justice Initiative, a non-profit advocacy organization based in Montgomery. EJI published "Lynching in America: Confronting the Legacy of Racial Terror."

Since the report's release, EJI has supplemented its original research by documenting racial terror lynchings in states outside the Deep South.

On June 15, 1920, a mob dragged Elias Clayton, Elmer Jackson and Isaac McGhie, employees of the John Robinson Circus, from their jail cells and lynched them for allegedly raping Irene Tusken, a 19-year-old, although Dr. David Graham's examination of Tusken found no evidence of sexual assault.

That information did not prevent newspapers from publishing numerous stories about the alleged rape.

The story about the lynchings is told in the 1979 book "The Lynchings in Duluth," by Michael Fedo. A photo of the three men who had been lynched was made into postcards at the time and shown throughout Duluth.

Bob Dylan's song "Desolation Row" recalls the lynching. Dylan was born in Duluth but grew up in Hibbing, Minnesota.

The 1919 Will Brown lynching in Omaha, Nebraska, witnessed by future Academy Award winner Henry Fonda Future Academy Award winning actor Henry Fonda witnessed the 1919 lynching of Will Brown in his hometown of Omaha, Nebraska, when he was a boy.

Fonda was born in 1905.

Will Brown White terrorists burned Brown, a 40-year-old meat-packing worker, at the stake for allegedly raping a white woman.

"It was the most horrendous sight I'd ever seen... My hands were wet and there were tears in my eyes.

All I could think of was that young black man dangling at the end of a rope," Fonda said.

EJI also released a study about Black military veterans targeted for lynching.

The report's title is "Lynching in America: Targeting Black Veterans." It builds on EJI's 2015 report, "Lynching in America: Confronting the Legacy of Racial Terror." More than 90 percent of terrorist lynching victims were black men, and some of the victims were

boys as young as 12 and 13, Stevenson told North-Star News Today.com and BlackmansStreet.Today in 2015. The study noted that at least 800 more African-Americans were murdered in lynchings than had been

previously reported. The report focuses on racial terrorist lynching, which Whites, including the police, elected officials, ordinary citizens and federal bureaucrats participated in the murders or condoned

them to enforce Jim Crow laws and racial segrega-



tion. Terror victims were murdered without being accused of any crime; they were killed for minor social transgressions, including bumping a White person, wearing their military uniforms after World War I

and not using the appropriate title to address a White person. For example, General Lee, a Black man, was lynched in 1904 by a White mob in Reevesville, Ga., for knocking on the door of a White woman's home.

Jim Caviezel, who previously portrayed Jesus Christ, is in negotiations to return.





Seven states file lawsuit to end DACA program

A coalition of seven states filed a lawsuit against the federal government Tuesday to end the Deferred Action for Childhood Arrivals program.

Texas Attorney General Ken Paxton and attorneys general from Alabama, Arkansas, Louisiana, Nebraska, South Carolina and West Virginia filed the suit saying the Obama-era program, which protects hundreds of thousands of children of undocumented immigrants from deportation, is unconstitutional.

"Our lawsuit is about the rule of law, not the wisdom of any particular immigration policy," Paxton said.

"Left intact, DACA sets a dangerous precedent by giving the executive branch sweeping authority to ignore the laws enacted by Congress and change our nation's immigration laws to suit a president's own policy preferences."

The lawsuit urges the

U.S. District Court for the Southern District of Texas to declare DACA unlawful and stop the federal government from issuing or renewing any DACA permits in the future.

It doesn't request the federal government remove any DACA recipients or rescind previously issued DACA permits.

Last week Judge John D. Bates of the U.S. District Court for the District of Columbia ordered the Department of Homeland Security to resume accepting DACA applications if the agency was unable to provide a legal reason to end the program within 90 days.

Two other federal judges, in New York and California, previously blocked President Donald Trump's efforts to end DACA on the principle his administration hadn't offered legally adequate reasons to rescind the program.

The Mexican American Legislative Caucus condemned the lawsuit as a misuse of taxpayer

money.

"Instead of wasting taxpayer funds to pick on these Americans without status, the attorney general should join the bipartisan chorus calling on Congress to fix a broken immigration system that denies these kids their rightful place at the American table," the caucus wrote on Twitter. Texas state Sen. José Menéndez, a Democrat, also issued a statement defending DACA recipients. "It has been widely ac-

cepted that children who are covered under DACA who are brought to this country as children through no fault of their own have done well in our educational settings, have done well in the workforce, have served our nation's armed forces with distinction," he said.

Texas poised to elect first Latina congresswomen

Texas appears poised to send its first Latina representatives to Congress this fall following Tuesday night's primary elections.

Texas Sen. Sylvia Garcia of Houston and former El Paso County Judge Veronica Escobar were officially nominated as the Democratic candidates for two open House seats that are considered locks for the party in November.

Garcia, 67, won her bid for the Democratic nomination in District 29 to replace U.S. Rep. Gene Green, also a Democrat.

A runoff will determine the Republican nominee. At her post-election party, she said the victory is not just hers. "This is all of our vic-

tory," she said. "I wanted Latino girls and boys to know this is a state of opportunity and it's a welcoming state. You have to work hard and believe in yourself and you can do it." A tweet posted by Garcia after her win Tuesday thanked her team for a "progressive movement proved that people speak louder than money."

Escobar, 48, is vying in District 16 to replace U.S. Rep. Beto O'Rourke, who won a bid Tuesday to try and unseat Republican Sen. Ted Cruz in November. After claiming her nomination, Escobar said the results are humbling, especially after facing so many obstacles such as fundraising, which is a huge component and challenging for those with limited networks.

"I think many of us have gotten to the point where we say forget the obstacles, we just got to get this done," Escobar said.

"There's just too much at stake." Escobar also sent a thank you tweet to supporters, thanking the city of El Paso for their votes.

Another first could take a Texas seat if a runoff election in San Antonio is won. Filipina-American Lawyer Gina Ortiz Jones, a former Air Force intelligence officer, would be the first openly lesbian veteran in Congress.
