Trump to visit communities in Dayton, El Paso on Wednesday

President Donald Trump will visit communities in Dayton, Ohio, and El Paso, Texas, on Wednesday, where gunmen killed more than 30 people in separate attacks last weekend.

Trump is scheduled to first visit Dayton, arriving at Wright-Patterson Air Force Base at 10:35 a.m. EDT. He will leave for El Paso about two hours later, and arrive about 3:45 p.m. EDT and stay in the border city for nearly three hours, the White House said.

El Paso Mayor Dee Margo, a Republican, said Tuesday he plans to welcome Trump but acknowledged he's received messages of opposition from residents. He said Trump has been "very gracious" with his support and his focus remains on the community, not politics.

Gilroy, El Paso, Dayton and the normalization of violence

As a bad Catholic, I need to make a confession: I no longer pay attention to mass shootings.

If I see a headline in the newspaper or online, I skip over to another story. If it comes up on my NPR podcast, I touch the arrow that advances me to the next story. If it is on CNN, I switch to the Hallmark channel.

I feel guilty, but I simply cannot take it anymore. I am sick of the violence and our country's inability to do anything about it. I see no point in listening to the same story over and over again.

News stories about mass shootings always follow the same 10-point template: 1. initial confusion about what happened; 2. on-site interviews with those who escaped the scene; 3. talking heads speculate about the motive of the gunman; 4. a press conference by police chief and mayor; 5. calls for greater gun control from Democrats; 6. calls for thoughts and prayers from Republicans; 7. a Trump tweet; 8. more speculation on motive of gunman; 9. coverage of funerals; 10. interviews with victims' families.

Nothing changes, except people buy more guns.

We move on to other news until the next shooting. It doesn't matter where the shooting takes place -- gay bar, church, primary school, university, shopping center, baseball game or on the street. Nothing shocks us enough to make us demand change.

And yet, mass shootings are only a minor contributor to the deaths from gun violence. Gun violence is common in most inner cities, but it gets little coverage in newspapers read by the white community. And gun suicides, spousal shootings, and accidents are so common that even white victims are ignored unless a child is involved.

I am afraid that others may soon respond to mass shootings that same way I do, the same way we do to other gun violence -- ignore it and move on. No matter how horrible something is, if it is repeated time and time again, we get accustomed to it.

We can't let this happen. Religious leaders cry out but few listen. From Rome, Pope Francis took notice of the shootings in El Paso and Dayton on Saturday and Sunday, where at least 29 were killed and dozens more were injured. These followed closely after the killings at the garlic festival in Gilroy, Calif. Texas Cardinal Daniel DiNardo, president of the U.S. Conference of Catholic Bishops, called the shooting "terrible, senseless and inhumane."

Franciscan Bishop John Stowe of Lexington, Ky., tweeted: "More senseless gun killings... more white nationalism... more disregard for the sanctity of human life... We need to create the beloved community Jesus envisions now." Many Catholic leaders have called for government action to curb gun violence. In their 2000 pastoral statement on criminal justice, the bishops wrote, "We support measures that control the sale and use of firearms and make them safer (especially efforts that prevent their unsupervised use by children or anyone other than the owner), and we reiterate our call for sensible regulation of handguns." For many years, the USCCB has supported what it calls "reasonable measures" to address the problem of gun violence. These include: A total ban on assault weapons, which the USCCB supported when the ban passed in 1994 and when Congress failed to renew it in 2004. Measures that control the sale and use of firearms, such as universal background checks for all gun purchases. Limitations on civilian access to high-capacity weapons and ammunition magazines. A federal law to criminalize gun trafficking. Improved access to and increased resources for mental healthcare and earlier interventions. Regulations and limitations on the purchasing of handguns. Measures that make guns safer, such as locks that prevent children and anyone other than the owner from using the gun without permission and supervision.

OPINION When debt becomes a life sentence: The rise of terminal debt

Debt is quickly becoming a new form of modern slavery in this country.

With people becoming increasingly more willing to spend on consumer items and lifestyle enhancements before they actually earn the money, debt is increasingly common.

To be clear, there is both good and bad debt.

Good debt is the use of leverage to invest in a business or acquire new skills that can increase one's earning capacity well beyond the cost of borrowing.

Bad debt is using borrowed money to fund current expenses and lifestyle foreseen medical expense, choices like vacations, clothing and nights out on off from a job or some other the town, and declining catastrophic occurrence. assets like cars and home appliances.

Since the Great Recession, many Americans should have been forced to cut back on their lifestyle spending because they were earning less income.

But instead of tightening their belts, all too many people have chosen instead to finance lifestyle with debt.

That debt, in the form of credit cards and home equity loans, often comes at an exceedingly high price.

Even borrowing for educational purposes has become a victim of lifestyle extravagance.

Student loan debt eclipsed all other forms of debt except for mortgage debt for the first time in 2018. According to Bloomberg, student loans surpassed home equity revolving debt, car loans and even credit card debt in the aftermath of the Great Recession. The reasons for this are myriad but can mostly be attributed to the fact that other traditional forms of debt have become highly regulated, whereas student loan debt, most of it in the form of government subsidized and/or guaranteed loans, has become the new credit card. As of last year, "Overall consumer debt reached a record \$13.5 trillion," Bloomberg reports, while student loan debt ballooned to a record \$1 trillion. This begs the question: Did the students who borrowed over \$1 trillion receive educational benefits that enable them to repay that amount?

Nobel Prize-winning author Toni Morrison dies at 88

Author Toni Morrison, the first African American to win the Nobel Prize for literature, died Monday at a New York hospital at age 88.

She is best known for works including Beloved, Tar Baby, Song of Solomon, Sula and The Bluest Eye. Morrison was a professor at Yale and Princeton universities.

In 2012, President Barack Obama awarded her

the Presidential Medal of Freedom.

"It is with profound sadness we share that, following a short illness, our adored mother and grandmother, Toni Morrison, passed away peacefully last night surrounded by family and friends," the family said in a statement. "She was an extremely devoted mother, grandmother and aunt who reveled in being with her family and friends. The consummate writer who treasured the written word, whether her own,

her students' or others', she read voraciously and was most at home when writing. Although her passing represents a tremendous loss, we are grateful she had a long, well-lived life."

Morrison became the first African American woman to win the Nobel Prize in literature in 1993. She was also the first U.S.born author to win since John Steinbeck in 1962. At the time, she said she was "profoundly honored" to win the award. "The most meaningful thing to me

4 dead, including gunman, after Atlanta-area shooting

Georgia authorities are investigating a triple homicide in the Atlanta area late Tuesday that ended with the gunman killing himself, investigators said.

DeKalb Police Sgt. J.D. Spencer said the gunman killed two women and a man outside a home in Stone Mountain before shooting himself.

Police said they found the shooter 2 miles away with a self-inflicted gunshot wound.

While authorities are not yet sure of a motive, they said they believe the killings resulted from a domestic dispute.

DeKalb Police Maj. Jerry Lewis said the killer and his victims all knew each other, but their full relationships were not immediately understood.

The shootings coincide



with a surge in U.S. gun violence over the last two weeks.

More than 30 people were killed in separate at-

tacks in Texas and Ohio last weekend, and three died in an attack at a summer festival in Northern California the weekend before.

Florida governor hands Jeffrey Epstein case to state law enforcement

Amid conflict of interest concerns, Florida Gov. Ron DeSantis signed an executive order Tuesday directing the state's law enforcement agency to take over an investigation into "irregularities" surrounding the decade-old Jeffrey Epstein case and 2008 plea deal.

Epstein, the 66-year-old multimillionaire currently facing multiple federal charges of child sex trafficking in New York, faced similar indictments in the late 2000s in Florida.

Former Miami prosecutor Alexander Acosta offered him a plea deal dropping more serious charges against him while also halting a federal investigation if he pleaded guilty to two lesser charges of soliciting prostitution. Epstein accepted the deal and was handed a 13-month sentence, the majority of which he spent

on work release.

The executive order directs the Florida Department of Law Enforcement to probe Epstein's work release program and to take over the Palm Beach County Sheriff's Office's ongoing criminal investigation into its prior investigation and case against Epstein.

"The Department of Law Enforcement may initiate a preliminary inquiry beyond the work release of Jeffrey Epstein and into other irregularities surrounding the prior state investigation and the ultimate plea agreement," the executive order said.

The executive order was in response to a request from Palm Beach County Sheriff Ric Bradshaw to DeSantis Tuesday that the investigation be handed over to the FDLE following accusations of conflict of interest as his office conducted the original case against the businessman.

The impact of Trump's vile racist rhetoric; The hate that hate produces

"Sadly, the overwhelming amount of violent crime in our major cities is committed by Blacks and Hispanics..." - Trump Tweet 6-5-13

"They (Democrats)

don't care about crime and want illegal immigrants, no matter how bad they may be, to pour into and infest our Country, like MS-13. -Trump Tweet 6-19-18

"Why are we having all these people from shithole countries come here?" -Trump 1-11-18

On August 3, 22 people

were killed, and dozens injured in a shooting at a Walmart in El Paso, Texas. Authorities have uncovered a document that they believe links the shooter's actions to his dismay at the increasing Hispanic population in Texas.

On April 27, 2019, one woman was killed, and three other people were injured at the Chabad of Poway synagogue in Poway, CA. In an antisemitic and racist open letter posted on 8chan shortly before the shooting and signed with the shooters name, the author blamed Jews for alleged "white genocide" ...a conspiracy theory, which he referred to as the "meticulously planned genocide of the European

race". On October 27, 2018, eleven people were killed and seven (including the perpetrator) were injured at the Tree of Life synagogue in Pittsburgh, Pennsylvania. Citing the Central American migrant caravans and immigrants, the shooter posted on "Gab" shortly before the attack that "HIAS likes to bring invaders in that kill our people. I can't sit by and watch my people get slaughtered..."

At least three people were killed, and 12 others wounded in a shooting at the Gilroy Garlic Festival in Northern California on Sunday, July 28. Nine people were killed, and 27 others injured in Dayton, OH Sunday, August 4. Police have yet to determine the motive in these shootings.

Much has been made of President Trump's racist and xenophobic Tweets and rants.

The discussion now centers around the "rise" of white supremacist language, web sites, activity and action. Analysts and others are trying to assign blame to President Trump for inciting this hatred and violence...but this is not new; this is America! To quote H. Rap Brown, "violence (and in this case racism) is as American as cherry pie".

America as a settler colonial state was founded upon violence, racism, bigotry and hatred. This month America commemorates the 400 years that enslaved Africans arrived on the shores of Port Comfort, Va. in 1619.

It's codified in the Constitution. Article 1, Section 2 of the US Constitution -Better known as the 3/5ths compromise. Article IV, Section 2, Clause 3, - The Fugitive Slave Clause and Article 1, Section 9 – the importation of enslaved Africans was allowed for 25 years after the Constitution was ratified.

The Indian Removal Act was signed into law on May 28, 1830, by President Andrew Jackson. The act has been referred to as a unitary act of systematic genocide as countless numbers of Chickasaw, Choctaw, Creek, Seminole, and Cherokee people (including mixed-race and Africans who lived among them) were forcibly removed from their ancestral lands in the Southeastern United States and forced to relocate west of the Mississippi.

It will never be determined how many people perished during this process also known as The Trail of Tears.

The Supreme Court was very clear in its language on March 6, 1857, Chief Justice Roger Taney issued what is widely regarded as the worst Supreme Court opinion ever in the infamous Dred Scott v. Sanford case, "[African Americans] had for more than a century before been regarded as beings of an inferior order, and altogether unfit to associate with the white race, either in social or political relations; and so far inferior, that they had no rights which the white man was bound to respect..." These are just a few examples of the historic basis of President Trump's racist tropes, but Trump is not alone. On the evening of March 21, 1915, President Woodrow Wilson attended a special screening at the White House of THE BIRTH OF A NATION, a film directed by D.W. Griffith and based on THE CLANSMAN, a novel written by Wilson's good friend Thomas Dixon. It depicted the Ku Klux Klan as valiant saviors of a postwar South, ravaged by Northern carpetbaggers and immoral freed blacks. The film helped to revive the Klan and its domestic terror in African American and Jewish communities. Even the beloved Ronald Reagan (Obama's favorite) was clear in his racism. According to Slate, In 1971, when both then-CA governor Reagan and President Nixon were frustrated about a United Nations vote to recognize the People's Republic of China. African delegations sided with others in supporting Chinese sovereignty over Taiwan. In a racist phone call to President Richard Nixon Reagan said, "To see those, those monkeys from those African countries-damn them, they're still uncomfortable wearing shoes!" Reagan said, to laughter from Nixon.

R. Kelly faces new sexual misconduct charges in Minnesota

Prosecutors in Minnesota on Monday levied new charges against singer R. Kelly for allegedly soliciting a minor in 2001.

Hennepin County attorney Mike Freeman said the charges stem from an encounter Kelly, born Robert Sylvester Kelly, had with a minor fan who asked for his autograph. They allegedly had sexual contact, but not intercourse, at a Minneapolis hotel.

"After some discussion she was offered \$200 to take off her clothes and dance for him," Freeman said. "After accepting the \$200 she got naked and

they proceeded to dance." He said Kelly also gave her VIP tickets to his concert and suggested she travel with him to a concert in Chicago.

"This kind of conduct, particularly juveniles, is simply unacceptable in the state of Minnesota and frankly everywhere," Freeman said. "She was a juvenile at the time, we have special laws to protect our juveniles, and we are going to enforce them." Kelly faces one count of prostitution with an individual under 18 and one count of soliciting sex with a person under 18 --both felony charges.

Kelly's attorney, Steven Greenberg, denied the allegations.

The Gulf's dead zone is an area that spans thousands of square miles just off the coast and where no fish can survive. It is created year after year, mainly by fertilizers that run off Midwestern agricultural fields. The fertilizers travel to the Gulf down the Mississippi River. Once there, they stimulate intense algae growth. That overly thick algae con-

sumes all the oxygen in the water, choking out the other marine life.

"Just like people, anything living in the water requires oxygen to breathe," said David Kidwell, a lead scientist with the National Oceanic and Atmospheric Administration's National Centers for Coastal Ocean Science. "That oxygen is dissolved in the water. And when that dissolved oxygen level is low, it causes things to die off." Thousands of species of marine plants and animals live in the Gulf, including shrimp, crabs, oysters, squid, octopus and corals. Animals that can swim, like fish or shrimp, simply leave the zone once the oxygen is depleted. Those that cannot swim usually die. This lowoxygen -- or hypoxic -- area has existed in the Gulf for decades. Scientists began measuring it in the 1980s. On average, the dead zone has not changed much for decades, said Dan Obe-

nour, an assistant professor of civil, construction and environmental engineering at North Carolina State University who works with a team of scientists to predict the dead zone's annual size. "The nutrient load ... plateaued in the late 1980s, and we haven't had much

success at changing that," Obenour said.

But the situation could worsen because, while the amount of fertilizer applied to America's cropland hasn't changed, the percentage of that fertilizer carried into the Gulf is expected to increase, said Craig Cox,

senior vice president for agriculture and natural resources at the Environmental Working Group. The latest climate models, produced by the federally mandated U.S. Global Change Research Program, predict that springtime in the Midwest will become wetter.
